ASSIGNMENT

WHEREAS, Herbst Lazar Bell Inc. (hereinafter "Assignor") an Illinois corporation, having a place of business at 345 Canal Street, Chicago, Illinois, is the owner by assignment of the entire right, title and interest in and to a certain original and ornamental design described and claimed in application for Design Letters Patent of the United States of America for a FUEL DISPENSING UNIT OR SIMILAR ARTICLE.

Assignor hereby requests that said Design Letters Patent be issued in accordance with this assignment.

Assignor further covenants and agrees that, at the time of the execution and delivery of these presents, Assignor possesses full title to the invention and application above-mentioned, and that it has the unencumbered right and authority to make this assignment.

Assignor further covenants and agrees, and likewise binds its heirs, legal representatives and assigns, to promptly communicate to said Assignee or its representatives any facts known to them relating to said invention, to testify in any interference or legal proceedings involving said invention, to execute any additional papers which may be requested to confirm the right of the Assignee, its representatives, successors and assigns to secure patent or similar protection for the said invention in all countries and to vest in the Assignee complete title to the said invention and Design Letters Patent, without further compensation, but at the expense of said Assignee, its successors, assigns and other legal representatives.
