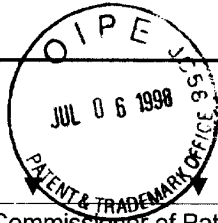

ASSIGNMENT

This Assignment is made by JONATHAN S. STRAUSS of Los Angeles, California and CHRISTOPHER L. FELTEN of Northridge, California (“Assignors”) to CEDARS-SINAI MEDICAL CENTER, a California corporation, having a place of business at 8700 Beverly Boulevard, Los Angeles, California 90048-1865 (“Assignee”).

WHEREAS, Assignors have invented a new and useful SYSTEM FOR ATTENUATING PAIN DURING BONE MARROW ASPIRATION AND METHOD, for which an application for United States Letters Patent was filed on May 7, 1998 in the United States Patent and Trademark Office and assigned Serial No. 09/074258 and identified as Attorney Docket No.: P07 40048;
