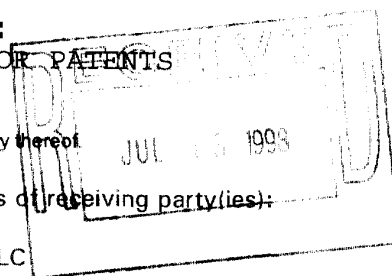


enjoyed by ASSIGNOR, if this assignment and sale had not been made.


