Rossman, residing at 89 Park Road, Chelmsford, Massachusetts 01824, hereby acknowledge and correct an error in the original Assignment of the patent applications identified on Schedule A attached hereto. The original Assignment erroneously identified the Assignee as PixelVision, Inc. rather than PixelVision Technology, Inc. The error occurred because PixelVision, Inc., and PixelVision Technology, Inc. merged, and PixelVision Technology, Inc. is the surviving corporation of that merger. However, the patent counsel for PixelVision, Inc. and PixelVision Technology, Inc. who prepared the assignment containing the erroneous name had not been informed of the merger prior to the preparation and execution of the assignment and we, the inventors, did not notice the error when we executed the assignment.

And we hereby covenant that we have full right to make such assignment, and agree for ourselves and our executors and administrators that we will, at the expense of said PixelVision Technology, Inc., execute all applications for patents in foreign countries, execute all divisional, continuing, reissue and re-examination applications, make all rightful oaths, sign all lawful papers, testify in any proceeding in which any of said inventions or any application or patent directed thereto may be involved, and generally do everything possible to aid said PixelVision Technology, Inc., its successors and assigns, to obtain and enforce proper patent protection for said inventions in the United States, its territories and all foreign countries.
