**ASSIGNMENT**

WHEREAS, Hans-Helmut Miegitz, Alfred Mai and Andreas Gross, hereinafter called the "Assignors", have made the invention described in the United States patent application entitled CONTAINER IN A MOTOR VEHICLE FOR STORING DRINKS AND/OR FOOD, for a full description of which reference is here made to an application for Letters Patent of the United States filed on March 17, 1998 and assigned Application Serial No. 09/042,756;




