

ASSIGNMENT

WHEREAS, we, Nevin C. Jenkins, Rande W. Newberry and Antonio Lebron, citizens of the United States, residing at Homosassa, Florida, Palm Harbor, Florida, and Spring Hill, Florida, respectively, (hereinafter referred to as the "Assignors"), have invented certain new and useful improvements in a "Method and Apparatus For Creating Art On An Object Such As The Nail Of A Person's Digit Or A Golf Ball", for which application for a United States Letters Patent Serial No. 09/076,790, was filed in the United States Patent and Trademark Office on May 13, 1998; and

WHEREAS, Fashion Nails, Inc. a corporation organized and existing under the laws of Florida, having a place of business at 1760 South Dimensions Terrace, Homosassa, Florida 34448 (hereinafter referred to as "Assignee"), is desirous of acquiring the Assignors' entire right, title and interest in and to the said invention, and in and to the said application, and any Letters Patent that may issue thereon;

The Assignors also hereby sell and assign to the Assignee, its successors and assigns, their foreign rights to the invention disclosed in said application, in all patent-granting countries of the world, including the right to file applications and obtain patents for said invention in its own name in said countries and including all rights of priority in said countries under the terms of the International Convention for the Protection of Industrial Property, and any other treaties, and the Assignors further agree to execute any and all patent applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such patent rights.

The Assignors also hereby agree, at the request and expense of the Assignee, to testify in any legal proceedings, sign all lawful papers, make all lawful oaths, and generally do everything possible to aid said Assignee, its successors and assigns, to obtain, maintain and enforce proper patent protection for said invention in all countries.
