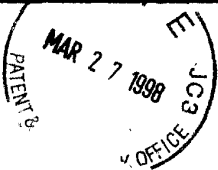



On the second page of the Assignment document in which Samuel Gazit is listed as the conveying party, the execution of said document is listed as 15/3/98 to the left of his signature. The conveying party, Samuel Gazit, resides in Israel and this notation for the listing of the date is according to the European practice of first listing the day and then listing the month before the year. The Recordation Cover Sheet which was filed with the documents, a copy of which is resubmitted, indicated that the document listing Samuel Gazit as the conveying party has an execution date of 3/15/98. Applicants' Attorneys have simply converted the European style date of 15/3/98 to the conventional U.S. style of 3/15/98 on the Assignment Recordation Cover Sheet.

Thus, Applicants submit that a document was properly submitted which verifies the execution date (March 15, 1998) of the Assignment from Samuel Gazit to World Properties, Inc.


