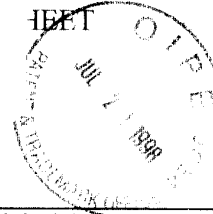

ASSIGNMENT

WHEREAS, **Thierry JOSSE; Jose Javier Cabero COMBARROS; and Miguel Cobo ESTEBAN** (hereinafter ASSIGNORS) of **Stockholm, SWEDEN; Madrid, SPAIN; and Madrid, SPAIN**; respectively, have invented a certain improvement in **DATA PACKET RADIO SERVICE WITH ENHANCED MOBILITY MANAGEMENT** for which a so-entitled application for Letters Patent of the United States was filed in the United States Patent and Trademark Office as a provisional application on June 20, 1997 and afforded Serial No. 60/050,306, and for which a second so-entitled provisional application was filed on July 11, 1997 and afforded Serial No. 60/050,232, and for which a so-entitled non-provisional patent application for Letters Patent of the United States was filed in the United States Patent and Trademark on **June 4, 1998** under Serial No. to be assigned:

representatives.

ASSIGNORS hereby agree to assist in the preparation of and hereby assign a like interest to said ASSIGNEE, its successors, assigns, and legal representatives, without further remuneration, any continuation, divisional, reissue, or foreign application claiming priority from the aforesaid application or otherwise growing out of or related to the invention; and to execute any papers by ASSIGNEE, its successors, assigns, and legal representatives necessary to ASSIGNEE's full protection and title in and to the invention hereby transferred.

ASSIGNORS specifically agree, upon request of ASSIGNEE, and without further remuneration, to execute any and all papers desired by ASSIGNEE for the filing and granting of foreign applications and the perfecting of title thereto in ASSIGNEE.


