




CORPORATE TO CORPORATE ASSIGNMENT

WHEREAS, Thermocorps, Inc., a corporation of the State of Delaware (hereinafter termed "Assignor"), owns rights, title, and interest in the inventions described in the patent applications and patents listed in the attached Table I (hereinafter "Said Inventions,") and

WHEREAS, Radiant Medical, Inc., a corporation of the State of California (hereinafter termed "Assignee"), is desirous of acquiring the Assignor's right, title and interest in and to Said Inventions, and in and to any and all patents, inventor's certificates and other forms of protection (hereinafter termed "patents") thereon granted in the United States and foreign countries.

1. 
