ASSIGNMENT

WHEREAS I, **RICHARD EDMOND FLETCHER**, a British Subject, of **The Fold, Bircher, Leominster, Herefordshire HR6 OAX, United Kingdom** have made a certain new and useful invention or inventions as set forth in a United States Letters Patent executed by me and bearing, Serial No. 09/116,275 filed July 16, 1998, entitled **TOILET AID FOR PARTIALLY DISABLED AND HANDICAPPED PERSONS**; the hereinafter named assignee being hereby authorized to insert the said Serial Number and filing date when ascertained.


