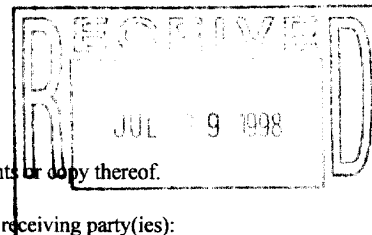

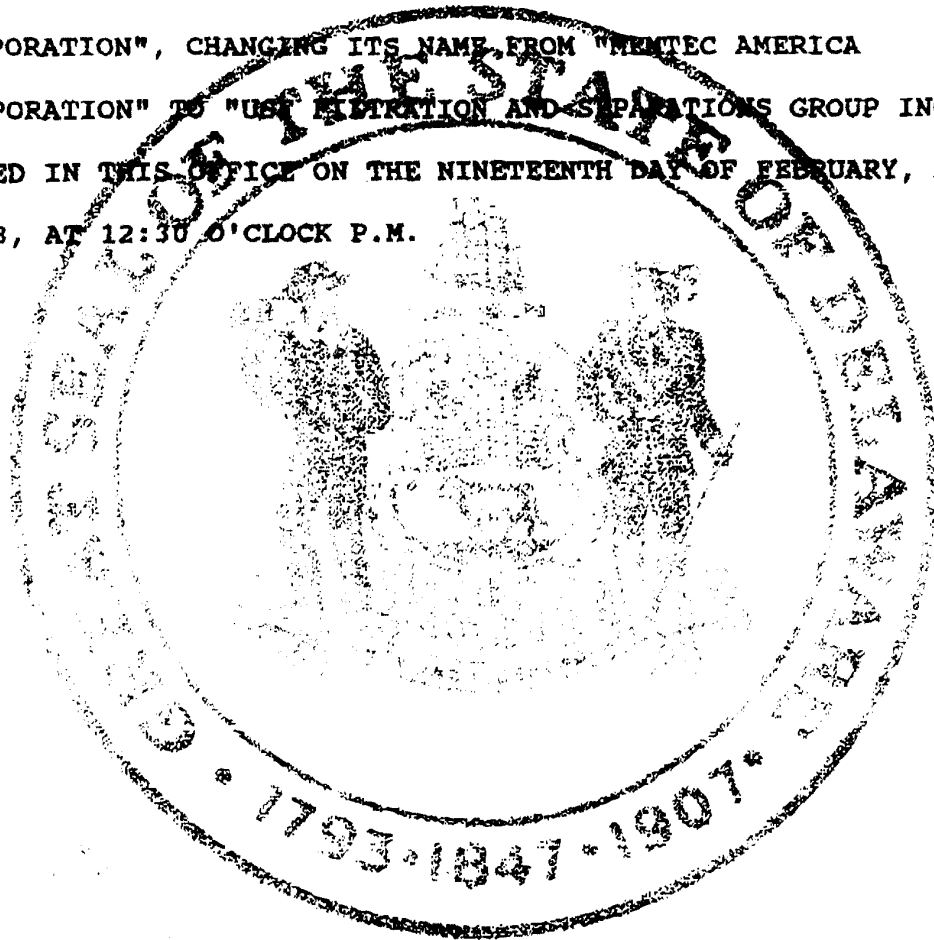

The name of the Corporation is USF Filtration and Separations Group Inc."

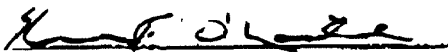
