

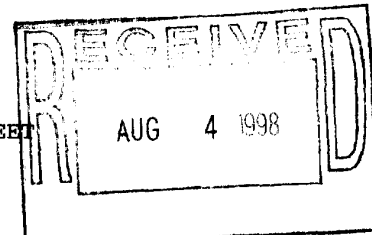

representatives.

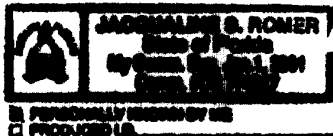
