PATENT ASSIGNMENT

THIS ASSIGNMENT, effective 4/8/78, WITNESSETH:

WHEREAS, Children's Hospital Los Angeles, having a place of business at 4650 Sunset Boulevard, Los Angeles, California 90027 (hereinafter "Assignor") is the owner of all right, title, and interest in and to the United States Letters Patent No. 5, 707, 865, and the inventions claimed in said identified patent (hereinafter "the Property"); and

WHEREAS, Genetic Therapy, Inc., having a place of business at 938 Clopper Road, Gaithersburg, Maryland 20878 (hereinafter "Assignee") is desirous of acquiring the entire right, title, and interest in and to the Property.

NOW, THEREFORE, for the consideration of one dollar (\$1.00) and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign, sell, transfer, convey and grant Assignee, its successors and assigns, the entire right, title, and interest in and to the Property, including the right to apply for, Letters Patent and certificates of invention in Assignee's name for the aforesaid inventions in the United States and all countries foreign thereto, and all reissues, extensions, renewals, divisions and continuations with respect to the Property, from the date hereof to the full end of the term or terms for which the Property may be issued, the same to be held and enjoyed by Assignee, its successors and assigns to the same extent that it would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor binds itself, as well as its successors, assigns and legal representatives to execute and deliver to Assignee, its successors and assigns, any further documents or instruments and do any and all further acts that may be necessary to vest in Assignee, its successors and

assigns, the title herein conveyed, or intended so to be, and to the extent possible to enable such title to be recorded in the United States Patent Office.

Assignor further covenants, and agrees that it will at any time upon request communicate to Assignee, its successors and assigns, any facts pertinent to the validity or enforceability of the Property and the history thereof, known to Assignor or to its executors and administrators, and that Assignor will at Assignee's expense testify as to the same in any interference or to other litigation when requested to do so by Assignee, its successors or assigns.
