

the same would have been held by us had this sale, assignment and transfer not been made;

AND WE AGREE TO execute upon request and without further consideration any and all instruments and documents for the filing and prosecution of applications for Letters Patent, including original, divisional, continuing, and re-issue applications, for the inventions assigned hereunder and for the assignment of the entire right, title, and interest therein to Imperial Chemical Industries PLC its successors and assigns;


AND WE DO HEREBY AUTHORIZE AND REQUEST The Assistant Commissioner for Patents of the United States, and any official of any country, or countries, foreign to the United States whose duty it is to issue patents on applications as aforesaid, to issue any said Letters Patent to IMPERIAL CHEMICAL INDUSTRIES PLC, its successors and assigns, as sole assignee.
