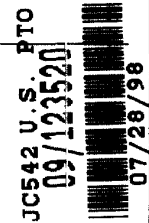

## ASSIGNMENT AND AGREEMENT

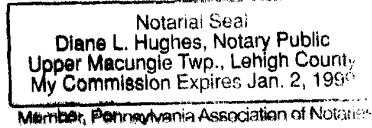

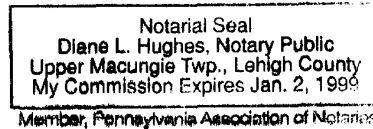


