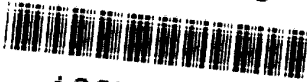

ASSIGNMENT

WHEREAS, we PETER J. KELLER and MICHAEL J. KELLEY of 520 Butler Drive, Lake Forest, Illinois 60045 and 825 East Davis Street, Arlington Heights, Illinois 60005 respectively, have invented certain new and useful improvements in OPTICAL STORAGE DEVICE for which we have executed an application for Letters Patent of the United States on the 21st day of July 1998; and

We do hereby authorize and request our attorneys, Trexler, Bushnell, Giangorgi & Blackstone, Ltd., of 105 West Adams Street, Chicago, Illinois 60603, to insert here in parentheses (Serial No. 09/111,989, filed July 8, 1998) the date and serial number of said application when officially known.

And we do hereby authorize and request the Commissioner of Patents to issue all Letters Patent of the United States that may be granted pursuant to the application aforesaid, or for said invention, to said ASSIGNEE, its successors and assigns, in accordance with this assignment.
