ASSIGNMENT

WHEREAS, I, **CARMEN MIRANDA BARCON**, hereinafter referred to as ASSIGNOR, a citizen of Spain, residing at Avda. Bularas n° 14, 28224 Pozuelo de Alarcon (Madrid), Spain

have invented certain new and useful improvements in **BRACELET**

I hereby authorize and request the Commissioner of Patents and Trademarks of the United States to issue all Letters Patent for said improvements to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute any agreement in conflict herewith.


