ASSIGNMENT OF PATENT RIGHTS

I, PETER ROITMAN, residing in Gaithersburg, Maryland, have co-invented with DEVENDSA K. SADANA, residing in Pleasantville, New York, "Silicon On Insulator Substrate Using Low Dose Implantation" and have filed an application for United States Letters Patent, Serial Number 08/961,131, filed on October 30, 1997.


