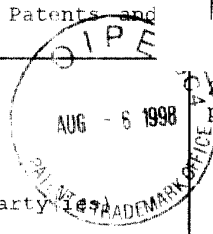

ASSIGNMENT

WHEREAS, Claude Charles Schauber of 85, Rue principale, 67160 Riedseltz, France (hereafter "Assignor(s)"), invented certain new and useful improvements in Process For Making A Viscosity Index Improving Copolymer, (hereafter "INVENTION") for which on the date below Assignor executed an application for Letters Patent of the United States of America;


