ASSIGNMENT

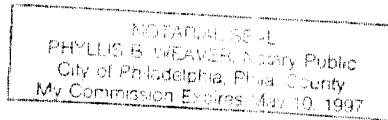

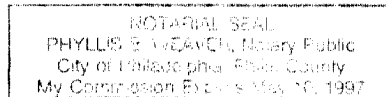
