THIS ASSIGNMENT is made the 25th day of April 1998

BETWEEN

- (1) J.H. FENNER & CO. LIMITED, a company incorporated in England and Wales under the Companies Acts (registered number 527331) and having its registered office at Welton Hall, Welton, Brough HU15 1PQ (hereinafter referred to as "the Assignor") and
- (2) FPT GROUP LIMITED, a company incorporated in Scotland under the Companies Acts (registered number SC177776) and having its registered office at 11 Walker Street, Edinburgh EH3 7NE (hereinafter referred to as "the Assignee")

WHEREAS:

- (A) The Assignor is the registered proprietor of the patent as set out in the Schedule hereto (the "Patent").
- (B) The Assignor has agreed to assign the Patent to the Assignee.

NOW THEREFORE THIS AGREEMENT WITNESSES THAT:

- (1) In consideration of the sum of £1 sterling (receipt of which is hereby acknowledged) the Assignor as beneficial owner hereby assigns to the Assignee the entire right, title and interest of the Assignor in and to the Patent and in and to the registrations thereof, including its right of action, power and benefit belonging or accrued arising therefrom and its right to take proceedings to recover damages and reclaim all other relief in respect of any act of infringement thereof whether such act shall have been committed before or after the date of this Assignment.
- (2) The Assignor and Assignee hereby agree that the change of ownership be recorded in the official Patents Register in each relevant country.
- (3) At the request of the Assignee, the Assignor hereby undertakes to take all actions and to execute all such further documents, forms and authorisations as may be required by any patent registrar (or

equivalent) or which may otherwise be necessary for absolutely vesting the rights hereby assigned in the Assignee or such member of the group of companies of which the Assignee is or is to become a member as the Assignee may nominate.

- (4) This Agreement shall be governed by and construed in accordance with English law and the parties hereby prorogate the non-exclusive jurisdiction of the English courts.






