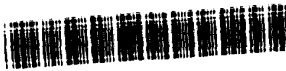
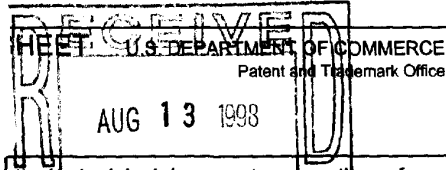

## ASSIGNMENT



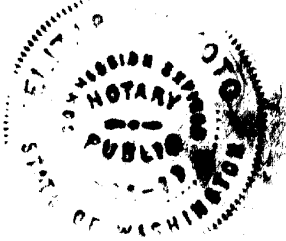
