RELEASE

WHEREAS, Wang Laboratories, Inc., a Delaware corporation (the "Debtor") granted a security interest to BT Commercial Corporation, as agent (the "Agent") in all of its intellectual property, including patents, patent applications, trademarks and trademark applications pursuant to a certain Borrower Intellectual Property Security Agreement (the "Agreement") dated as of January 30, 1995, which was filed at the United States Patent and Trademark Office on March 13, 1995 and recorded at Reel 7377 and Frame 072; and granted a further security interest to BT Commercial Corporation as collateral agent (the "Collateral Agent") pursuant to a certain Amended And Restated Intellectual Property Security Agreement (the "Amended Agreement") dated as of August 29, 1996, which was filed at the United States Patent and Trademark Office on November 29, 1996 at Reel 8246, Frame 0001;

WHEREAS, the Debtor has agreed to sell and transfer to Farrington Investments, Ltd. the specific items of Intellectual Property Collateral set forth on Exhibit A attached hereto (Patents and Patent Applications) (the "Patents"), pursuant to the Agreement for the Sale of Patents dated as of OCTOBER 31, 1997.

NOW, THEREFORE, the Agent and Collateral Agent hereby reassign to the Debtor all of their respective right, title and interest in the Patents and hereby release any security interest or lien in or against any of the Patents granted by the Debtor to the Agent and the Collateral Agent under the Agreement or the Amended Agreement or any other instrument or document executed by the Debtor.

The Agent and Collateral Agent agree that they shall, upon the Borrower's or Farrington Investments, Ltd.'s reasonable request, execute releases, instruments and termination statements and take any other actions necessary to effect or evidence of record the foregoing.

This release shall be binding on the Agent and the Collateral Agent and their respective successors and assigns and shall inure to the benefit of the Debtor and Farrington Investments, Ltd.
