ASSIGNMENT

WHEREAS, Wai Kai Wong, hereinafter called the "Assignor", has made the invention described in the United States patent application entitled LIGHT FLASHING SYSTEM, for a full description of which reference is here made to an application for Letters Patent of the United States filed on March 10, 1998 and assigned Application Serial No. 09/037,336;

The Assignor hereby covenants and agrees, for both the Assignor and the Assignor's legal representatives, that the Assignor will assist the Assignee in the prosecution of the patent application identified above; in the making and prosecution of any other patent


