## ASSIGNMENT

AND I, the said TIMOTHY PHILIP RICHARDS, do hereby authorize and request the Commissioner of Patents and Trademarks to issue the said Letters Patent of the United States to said MONDEX INTERNATIONAL LIMITED, as the assignee of the entire right, title and interest in and to the same, for the sole use and benefit of said MONDEX INTERNATIONAL LIMITED, its successors and assigns;
