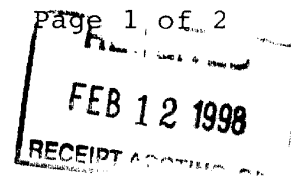

ASSIGNMENT

WHEREAS, I, Robert E. Vago, citizen of the United States of America, residing at 1671 East Mission Hills, Unit 311, Northbrook, IL 60062, have invented new and useful improvements in STORAGE APPARATUS, PARTICULARLY WITH AUTOMATIC INSERTION AND RETRIEVAL for which I am about to make application for Letters Patent of the United States, said application being executed by me on even date herewith.

WHEREAS, Cryo-Cell International, Inc. (hereinafter "CRYO-CELL"), a corporation organized and existing under the laws of the State of Delaware, having a place of business at 604 Packard Court, Safety Harbor, Florida 34695, is desirous of acquiring the entire right, title and interest in and to the application and invention therein described and claimed and any Letters Patent which may be issued upon the application or for improvements therein contained.

Now, THEREFORE, in consideration of my employment by said CRYO-CELL and other good and valuable considerations, to me in hand paid, the receipt and sufficiency of which are hereby acknowledged, I, , have sold, assigned and transferred and do hereby sell, assign and transfer unto said CRYO-CELL, its successors and assigns, our entire right, title and interest in and to the application and to the invention therein disclosed and the entire right, title and interest in and to any Letters Patent which may issue thereon, and the right to apply for any Letters Patent in the United States of America and in any and all foreign countries on said invention, including all divisional, renewal, substitute and continuation applications based in whole or in part upon said invention, or upon any and all Letters Patents that may issue thereon, and every priority right that is or may be predicated upon or arise from said invention, the same to be held and enjoyed by said CRYO-CELL, for its own use and enjoyment and for the use and enjoyment of its successors and assigns, to the full end of the term for which any said Letters Patent are granted, as fully and as entirely as the same would have been held and enjoyed by me had this Assignment and sale not

been made.

And I hereby authorize said CRYO-CELL to file patent applications in any or all other countries on said invention in my name or in the name of said CRYO-CELL or otherwise as said CRYO-CELL may deem advisable.

And I hereby authorize the empowered officials of all governments to issue or transfer any said Letters Patent granted, to said CRYO-CELL, as assignee of the entire right, title and interest therein or otherwise as said CRYO-CELL may direct, in accordance with this instrument or assignment.

In further consideration of said good and valuable considerations, I, , further represent and warrant to said CRYO-CELL, its successors and assigns, that there are no rights and interests outstanding inconsistent with the rights and interests granted herein and that I have not executed any instrument or granted or transferred any rights or interests inconsistent with the rights and interests granted herein and that I will not execute any instrument or grant or transfer any rights or interests inconsistent herewith, and I bind myself, my heirs, executors, administrators and legal representatives, as the case may be, to execute and deliver to said CRYO-CELL, its successors and assigns, and I hereby irrevocably appoint said CRYO-CELL as my true and lawful attorney-in-fact on my and their behalf and in my and/or their name, place and stead to execute, any further documents or instruments and do any and all further acts that may be deemed necessary or desirable by said CRYO-CELL, its successors and assigns, to vest in said CRYO-CELL, its successors and assigns, the title whose conveyance is made hereby, and to enable such title to be recorded in the United States and all other countries, and to enable said CRYO-CELL to sustain or reissue any said Letters Patent granted, and to maintain, perfect, support and protect the right, title and interest of said CRYO-CELL, its successors and assigns, in and to the said invention, and any Letters Patent granted, particularly in cases of interference and litigation.

And I further covenant and agree, in consideration of the premises, that I, my executors and administrators, will at any time upon request of said CRYO-CELL, its successors or assigns, and at its expense, communicate to said CRYO-CELL, its successors and assigns, any facts relating to the invention and improvements and the history thereof, known to me or my heirs, executors, administrators or legal representatives, and that I will testify as to the same in any interference, or other litigation when requested to do so by said CRYO-CELL, its successors and assigns.
