ASSIGNMENT

WHEREAS, we, Armin E. Mittermaier and Donald E. Rhodes, residing at 3401 Kirkwood Drive, Fort Wayne, Indiana 46805 and 1828 Woodland Lake Pass, Fort Wayne, Indiana 46825, having invented certain improvements in:

PLASTIC CONCRETE FORM

We hereby authorize and request the Patent and Trademark Office officials in the United States of America and the Patent Office officials of any and all foreign countries to issue any and all of said Letters Patent, when granted to said Poly Concrete Forms, Inc. as the

assignee of our entire right, title and interest in and to the same, for the sole use and enjoyment of said Poly Concrete Forms, Inc., its successors and assigns.
