ASSIGNMENT AND AGREEMENT


For value received, I, Gary L. Cox, of Richmond in the County of Wayne and State of Indiana, do hereby sell, assign and transfer to Vandor Corporation doing business at 1620 Rich Road, Richmond, Indiana 47374-1435 and its successors, assigns and legal representatives, the entire right, title and interest, for the United States of America, in and to certain inventions related to a CASKET TOP INTERIOR ASSEMBLY HAVING ROLL CLAMP described in a Patent Application of the United States, executed on even date herewith, and all the rights and privileges in said application and under any and all Letters Patent that may be granted in the United States for said inventions; and I also concurrently hereby sell, assign and transfer to Vandor Corporation the entire right, title and interest in and to said inventions for all countries foreign to the United States, including all rights of priority arising from the application aforesaid, and all the rights and privileges under any and all forms of protection, including Letters Patent, that may be granted in said countries foreign to the United States for said inventions.

I authorize Vandor Corporation to make application for such protection in its own name and maintain such protection in any and all countries foreign to the United States and to invoke and claim for any application for patent or other form of protection for said inventions, without further authorization from me, any and all benefits, including the right of priority provided by any and all treaties, conventions, or agreements.

I hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any document which may be required in any country in proof of the right of Vandor Corporation to apply for patent or other form of protection for said inventions and to claim the aforesaid benefit of the right of priority.

I request that any and all patents for said inventions be issued to Vandor Corporation in the United States and in all countries foreign to the United States, or to such nominees as Vandor Corporation may designate.

I agree that, when requested, I shall, without charge to Vandor Corporation, but at its expense, sign all papers, and do all acts which may be necessary, desirable or convenient in connection with said applications, patents, or other forms of protection.
