ASSIGNMENT

WHEREAS, Junichi Murakami, Takashi Hatanai and

Akihiro Makino

hereinafter called the "Assignors", have made the invention described in the United States patent application entitled METAK RIBBON MANUFACTURING APPARATUS

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
