

and in, to and under any reissue, divisional, continuing or substitute application thereof, together with the right to apply for Utility and/or Design Letters Patent, or to apply for Registration , Utility Model or other equivalent right in all foreign countries, and claim any priority rights to which such applications are entitled under international conventions, treaties, or otherwise, and the right to appoint attorneys of its choice to represent it in filing and prosecuting such applications, and in, to and under any Letters Patent, Design Registrations, Utility Models or equivalent rights that may be issued or granted in the United States of America and foreign countries; and I do hereby covenant and agree for myself and my legal representatives to assist said Assignee in the prosecution of

such applications, as may be required by said Assignee, all, however, at the expense of said Assignee; and I do hereby authorize and request the Commissioner of Patents and Trademarks of the United States of America, or corresponding officials of foreign countries, to issue said Letters Patent, Design Registrations, Utility Models or equivalent rights upon said applications for said Invention to DART INDUSTRIES INC. aforesaid, for the sole use and behoof of said Assignee, its successors and assigns.
