And I also hereby covenant and agree to sign all proper papers including divisional and other applications for patents and assignments thereof in the United States and application for patents and assignments in all countries foreign to the United States, and to execute all rightful oaths and to take any other proper action that may in the judgment of said Fuller and Orr be necessary for securing thereto full rights to said invention, all of the foregoing to be at the expense of said Fuller and Orr.
