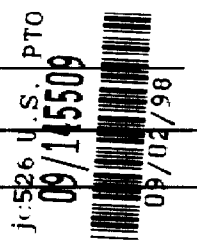



AND I DO HEREBY authorize and request the commissioner of Patents and Trademarks to issue the said Letters Patent, when granted, to the said EMERSON ELECTRIC CO., a corporation, its successors and assigns, as assignee of the entire right, title and interest in and to the said improvements, for the sole use and behoof of said EMERSON ELECTRIC CO., a corporation, and for its successors and assigns, to the full ends of the terms for which Letters Patent may be granted.

AND I further grant to EMERSON ELECTRIC CO., a corporation, its successors and assigns, the right to claim for any application for patent for said improvements the full benefit of any international agreement between the United States and any foreign country or countries.
