ASSIGNMENT

WHEREAS, James A. Simmons of 340 Fanwood Drive, Painesville Township, Ohio 44077 (hereinafter referred to as "I") have made an invention in a CUSHIONING CONVERSION SYSTEM FOR PRODUCING U-SHAPE PADS for which application for Letters Patent of the United States was executed even day herewith, and

WHEREAS, RANPAK CORP. I hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale;

I further covenant for myself and for my heirs, executors and administrators that RANPAK will, upon its request, be provided promptly with all pertinent or material facts and documents relating to said application, said invention and said Letters Patent and legal equivalents in foreign countries as may be known and accessible to me and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to RANPAK or its legal representative any and all papers, instruments or affidavits which RANPAK, its successors and assigns, may deem necessary in order to apply for, obtain, maintain, issue, enforce and to secure unto itself its successors and assigns the full right, title and interest in and to the full enjoyment of said application, said invention and said Letters Patent and said equivalents thereof in any foreign country which may be necessary or desirable to carry out the purposes thereof, the same to be done without any further consideration.

IN WITNESS WHEREOF, I hereby execute this Assignment on the date set after my signature.


