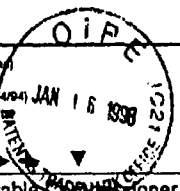



Cosmetics Co., Limited, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in the United States.


