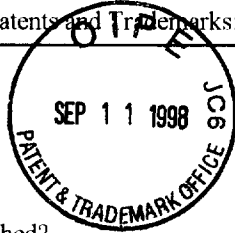

**ASSIGNMENT**

WHEREAS, I, Mohammed Memon, a citizen of Pakistan, residing at 46525 Hollymead Place, Sterling, Virginia 20165, have invented certain improvements in:

- (1) Homogenous Crumb Rubber Modified Asphalt, for which I have obtained U.S. Patent No. 5,704,971, issued January 6, 1998; and
- (2) Activated Method for Treating Crumb Rubber Particles, for which I have filed U.S. application Serial No. 08/988,949 on December 11, 1997; and

Said inventions, application and Letters Patent to be held and enjoyed by the said TharTech Inc. for its own use and behoof, and for its legal representatives or assigns, to the full end of the term for which said Letters Patents may be granted as fully and entirely as the same would have been held by me had this assignment and sale not been made.

Lawrence E. Laubscher, Jr. and Lawrence E. Laubscher, Sr., attorneys of record, are hereby granted the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark office for recordation of this document.
