ASSIGNMENT

WHEREAS, Thilaka S. Sumanaweera and Patrick J. Phillips, hereinafter called the "Assignor", has made the invention described in the United States patent application entitled Ultrasonic System And Method For Measurement Of Fluid Flow, executed by Assignor on the same date of this Assignment;

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
