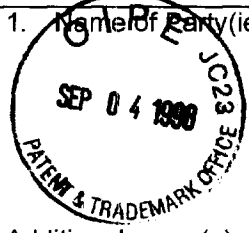

ASSIGNMENT

WHEREAS, Christopher R. Cole and C. Geoffrey E. Fernald, hereinafter called the "Assignor", has made the invention described in the United States patent application entitled Ultrasound Beamformation Integrated Circuit And Method, executed by Assignor on the same date of this Assignment;

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.


