WHEREAS, we are the joint inventors of certain new and useful improvements in **MODULATION SYSTEMS AND METHODS THAT COMPENSATE FOR DC OFFSET INTRODUCED BY THE DIGITAL-TO-ANALOG CONVERTER AND/OR THE LOW PASS FILTER THEREOF** for which an application for United States Letters Patent has been executed by us concurrently herewith, and
