foreign countries with full benefit of such priorities as may now or hereafter be granted to Assignor by local laws or by
treaty, including any international convention, for the protection of industrial property, together with the right to extend the
protection of said U.S. LETTERS PATENT to the various territorial possessions now owned or which may be hereafter
acquired by the United States of America, all said rights to be held and enjoyed by the Assignee for its own use and
benefit, and for the use and benefit of its successors or assigns, to the full end of the term for which said LETTERS
PATENT may be granted, as fully and entirely as the same would have been held and enjoyed by Assignor if this
assignment and sale had not been made. And Assignor does hereby request and authorize the Commissioner of Patents
and Trademarks, U.S.A., to issue said U.S. LETTERS PATENT, when granted, in accordance with this assignment.

Assignor further covenants and agrees with the Assignee that Assignor has a full and unencumbered title to the
invention hereby assigned, which title Assignor warrants unto the Assignee, and Assignor further agrees that Assignor will,
without demanding any further consideration therefor, at the request but at the expense of the Assignee, do all lawful and
just acts, including the execution and acknowledgment of instruments, that may be or become necessary for obtaining,
sustaining, extending, reissuing or reexamining United States and foreign LETTERS PATENT or the like for the said
invention, and for maintaining and perfecting the Assignee's right to said invention and LETTERS PATENT particularly
in cases of interference, conflict, opposition and litigation.

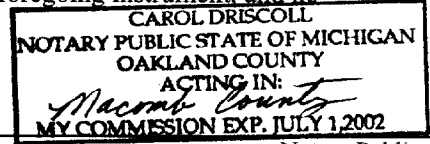
