

WHEREAS, I, Theodore Joseph Tine, Jr., a citizen of United States, reside at 244 Middlesex Turnpike; Chester; CT 06412 and have made certain inventions or discoveries (or both) as set forth in an application for Letters Patent of the United States of America, entitled **Manual Fuel Valve**, which application is being filed herewith;
