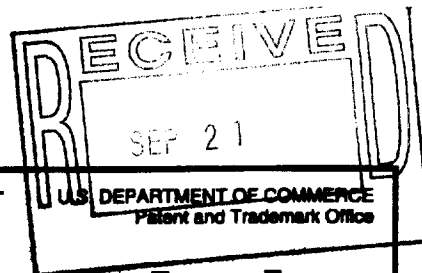

ASSIGNMENT

WHEREAS, we , Douglas F. Carey of One Clocktower Place, Apt. 303, Nashua, NH 03060-3377, Edward F. Dziadek of 3 Old New Boston Road, Mont Vernon, NH 03057 and Christopher M. Moritz of 135 Greenwood Court, Manchester, NH 03109, are the inventors of the invention APPARATUS FOR HIGH-PERFORMANCE SECTORED ANTENNA for which we have executed an application for a patent of the United States of even date herewith; and

WHEREAS, Spike Technologies, Inc., a Delaware corporation, having offices at 131 Varick St., New York, NY 10013 is desirous of obtaining the entire right, title, and interest in, to, and under the said invention and the said application:

AND I HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives, and assigns, in accordance with the terms of this instrument;


AND I HEREBY covenant and agree that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for said invention in all countries.




