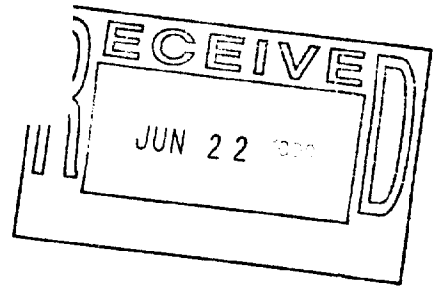



WHEREAS I, Michael J. Gallagher, residing at 325 Winnacunnet Road, Hampton, New Hampshire 03842, have invented certain new and useful improvements in an METHOD OF FORMING A MOTOR VEHICLE INSTRUMENT PANEL WITH A FLEXIBLY TETHER AIR BAG DEPLOYMENT DOOR for which I am about to make application for Letters Patent of the United States, which application may be identified in the United States Patent Office as Serial No. 08/426,104, filing date April 21, 1995; and

I DO HEREBY COVENANT and agree with the said assignee that I will not execute any writing or do any act whatsoever conflicting with these presents, and that I will at any time upon request, without further or additional consideration, but at the expense of the said assignee, execute such additional assignments and other writings and do such additional acts as said assignee may deem necessary or desirable to perfect the assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, renewal, reissued or extended Letters Patent of the United States or of any and all

foreign countries on said invention, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of the assigns and legal representatives of both parties.
