## ASSIGNMENT FOR UNITED STATES PATENT

WHEREAS, Rodrigo A. Garcia, a resident of 426 Mail Rt. Road, Montgomery, Texas 77356 U.S.A. and Joseph G. Gho, a resident of 2203 W. 20th Ave., Vancouver, British Columbia, Canada V6L 1G2, CANADA (hereinafter referred to as ASSIGNORS), own an interest in a certain invention entitled "Chemically Degradable Polyolefin Films", for which United States Letters Patent 5,565,503 have issued, and

Prior assignments of a parent application, Serial No. 07/933,685, from Rodrigo A. Garcia and Joseph G. Gho to GAIA Research Limited Partnership were recorded on 8/21/92 at Reel 6210/Frames 0271-0276; however, no assignments were ever filed for Serial No. 08/104,195, which is a continuation-in-part of that parent application and which issued as the above-referenced Letters Patent.






