ASSIGNMENT

WHEREAS we, Guido GORTAN of 21 Cité Bourgbierg
~~XXXXXX~~ L. 3335 HELLANGE and State of Luxembourg, and Maksimiljan CENCIC
of 2 rue des Saules, ~~XXXXXX~~ F. 57110 YUTZ and State of France
and XXXXXX, of XXXXXX, County of XXXXXX
and State of XXXXXX
have invented a new and useful improvement in Device for automatically stopping
the fall of personnel working high above ground
for which we are about to make application for Letters Patent of the United States; and

WHEREAS TRACTEL S.A.
hereinafter referred to as the "said COMPANY", a corporation organized and existing under the laws of the State of France
is desirous of acquiring the entire right, title and interest in said invention and in the Letters Patent to be obtained therefor;

NOW, THEREFORE, be it known that, for and in consideration of the sum of one dollar and other valuable considerations to us in hand paid by the said COMPANY, the receipt of which is hereby acknowledged, we, the said Guido GORTAN and Maksimiljan CENCIC
have sold, assigned and transferred, and by these presents do sell, assign and transfer unto the said COMPANY, its successors and assigns, the entire right, title and interest in and to the said invention, as fully set forth and described in the specifications prepared and executed by us on the 2nd day of February, 1998; preparatory to obtaining Letters Patent of the United States therefor, and the entire right, title and interest in and to said invention and any improvements thereon and any Letters Patent that may be obtained thereon in any country foreign to the United States, the same to be held and enjoyed by the said COMPANY, for its own use and behoof, and for the use and behoof of its successors and assigns to the full end of the terms for which said Letters Patent are or may be granted, reissued or extended, as fully and entirely as the same would have been held and enjoyed by us if this assignment and sale had not been made; together with all our right to make application for and obtain Letters Patent for the aforesaid invention and improvements outside of the United States.

And we hereby authorize and request the Commissioner of Patents to issue any and all Letters Patent of the United States when granted upon said invention and application or any renewals or divisions thereof, to said COMPANY, as assignee, or its successors or assigns, for the sole use and behoof of said COMPANY, its successors or assigns.

And we do covenant and warrant that we have full right to convey the entire interest herein assigned free and clear of all licenses, encumbrances and liens whatsoever, and that we have not executed and will not execute any instruments in conflict herewith.

We further agree that we will, at the request of the assignee, its successors or assigns, communicate to it or them, or its or their duly appointed representatives, all information which we possess relative to the invention aforesaid, and to the best mode of applying the same; and that, at the request of said COMPANY, its successors or assigns, we will, without further consideration, aid it or them to the best of our ability in any Patent Office Interferences involving said invention and in any litigation in which infringement is charged of any and all Letters Patent which may be granted therefor upon the said invention, or in which structures claimed to be built by the said COMPANY, or its successors or assigns, under any and all Letters Patent which may be granted upon said invention, are charged to be infringements of other patents, in which it or they may become involved and, if requested, will testify in its or their behalf in any such litigation.

And we further agree that we will at any time, upon request, execute and deliver, without further consideration, any papers that may be requested by the said COMPANY, its successors or assigns, to perfect the title to said invention or any Letters Patent that may be granted therefor; and that if the said COMPANY, its successors or assigns, desires to make application for Letters Patent on said invention in foreign countries, or to file divisional applications relating to said invention in this or any other country, or to secure the reissue or extension of any and all said Letters Patent, or to file a disclaimer relating thereto, we will cooperate with it or them to that end and will execute all papers, make all rightful oaths and do all acts requested of us by the said COMPANY, its successors or assigns, to effect the purposes of the rights herein conveyed.
