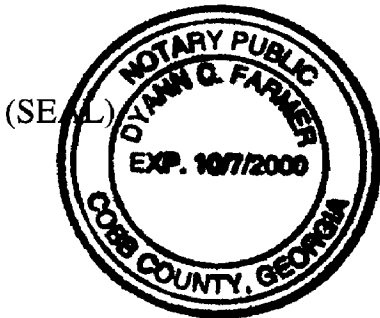
statutes, or regulations; said foreign applications to be filed and issued in the name **Cellemetry LLC**, or its designee insofar as permitted by applicable law.
