ASSIGNMENT

WHEREAS, I, Vivek Amir Jairazbhoy, of 31122 Pine Cone Drive, Farmington Hills, Michigan 48331; have invented certain new and useful improvements in PNEUMATICALLY-ACTUATED THROTTLE VALVE FOR MOLTEN SOLDER DISPENSER for which I am about to make application for Letters Patent of the United States; and
