
WHEREAS, Patentee executed a Patent Application Assignment dated September 19, 1997, which was not recorded, and this assignment is effective as if entered into on such date.

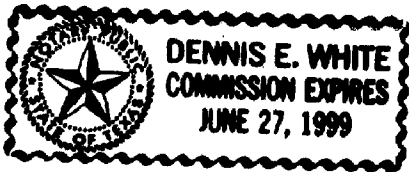

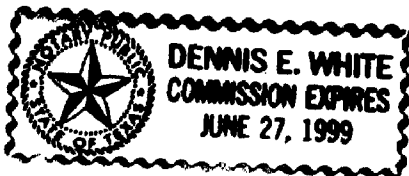
