Pursuant to the provisions of RCW 23B.10, the undersigned officer of Kangaroo, Inc., a Washington corporation, executes the following Articles of Amendment to the Articles of Incorporation of this corporation:

1. The name of the corporation currently registered with the Washington Secretary of State is Kangaroo, Inc.
2. The Articles of Incorporation of the corporation are amended by replacing Article I in its entirety with the following:

**ARTICLE I**

The name of the Corporation is **Punch Networks Corporation.**
