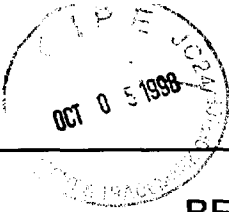

ASSIGNMENT

WHEREAS, I, Donald E. Yorde of Colgate, Wisconsin was adjudged by the Circuit Court of the State of Wisconsin, Waukesha County, in an Order for Judgment dated April 21, 1997 (the "Order") and recorded in the US Patent and Trademark Office at Reel 8568, Frame 0675, to be the owner of a 1/3 interest in the Letters Patent of the United States bearing Patent Numbers 4,794,089; 5,137,827 and 5,284,748 ("the Patents") as a matter of law, and

WHEREAS, thereafter I did enter into a Settlement Agreement and Mutual Release ("the Agreement") with Crystal Medical Products, Inc. (the "Company") and others on June 17, 1998 wherein I assigned to the Company, and released any interest that I may have had in, the Patents, and wherein I further acknowledged that I had no future rights to use or sell the inventions claimed in the Patents without appropriate license from the Patent holder, and wherein I agreed to execute and deliver any documents necessary to effectuate such Agreement, release and acknowledgment, and

WHEREAS, the record of title to the Patents is still encumbered by the Order, and


WHEREAS, the Company, an Illinois corporation having a place of business at 321 Spruce Street, Scranton, PA is desirous of removing any cloud of title and encumbrance on the Patents caused by the recording of the Order and of securing the entire interest in said inventions throughout the United States of America and the territories thereof, for all other countries and under all international agreements.

NOW, THEREFORE, for and in consideration of One Dollar (\$1.00) to me in hand paid, and other good and valuable consideration, receipt whereof is hereby acknowledged, I hereby acknowledge, confirm and agree that I have no rights in and to the Patents, and to the extent, if any, I had or have retained residual rights in and to the Patents, do hereby sell, assign and transfer unto said Company, its successors and assigns, the entire right, title and interest throughout the United States of America and the territories thereof, for all foreign countries and under all international agreements in and to said inventions, and all Patents granted thereupon by the United States, by any other country or under any international agreement.

I hereby warrant that I have the full right to make the conveyance herein.
