WHEREAS I, **GEORG BEHRINGER**, a citizen of Germany residing at Mauermatten Strasse 4, D-79183 Waldkirch, Germany, (hereinafter referred to as "ASSIGNOR"), have invented and own a certain invention entitled **AMUSEMENT PARK RIDE FOR THE PHYSICALLY DISABLED**, for which application for Letters Patent of the United States of America has been executed on even date herewith; and

WHEREAS, **UNIVERSAL STUDIOS, INC.**, a corporation organized and existing under and by virtue of the laws of the State of California and having its principal place of business at 100 Universal City Plaza, Building 488, 7th Floor, Universal City, CA 91608 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring the exclusive right, title and interest in, to and under any Patent or similar legal protection to be obtained therefor in the United States of America, its territorial possessions and in any and all countries foreign thereto.

foreign country for the full term or terms for which the same may be granted, except for Germany, including all priority rights under the International Convention; and ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks to issue said Letters Patent or any legal equivalent thereof to said ASSIGNEE, its successors and assigns, in accordance with this Assignment.

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement.

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Letters Patent and legal equivalents as may be known and accessible to ASSIGNOR and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention and said Letters Patent and said equivalents in the United States or in any foreign country, which may be necessary or desirable to carry out the purposes thereof.
